You acknowledge that this is a private consumer research event, and by attending any Screenings, you warrant that you are not a member of the entertainment, media or market research industries. No one will be admitted who appears to be intoxicated, under the influence of drugs or alcohol or are improperly dressed. If you appear to be intoxicated, under the influence of drugs or improperly dressed, or are found to be creating a disturbance or interfering with the enjoyment of other audience members, you will be refused admittance to the Screening and/or immediately removed from the premises. We reserve the right to refuse entry to anyone at our sole discretion.

### **Mobile Phones and Recording Devices**

Use of mobile phones will not be permitted in the auditorium.
